

ODISHA STATE TELE AWARDS (AMENDMENT) RULES – 2013

1. SHORT TITLE AND COMMENCEMENTS : -

- (i) These Rules shall be called – The Odisha State Tele Awards Amendment Rules-2013.
- (ii) These Rules shall come into effect from the date of notification of the Rules.

2. AIMS AND ELIGIBILITY :

- (i) The scheme of State Tele Awards for T.V. Serials / Tele Films aims at encouraging the production of T.V. Serials / Tele Films in Odia language of aesthetic excellence, high technical standards and social relevance.
- (ii) The Scheme of State Tele Awards for T.V. Serials / Tele Films envisaged under these Rules shall apply to T.V. Serials / Tele Films produced in Odia language within the State of Odisha.
- (iii) **(a)** The T.V. Serials / Tele Films produced by the Central Government or any Agency or largely owned by them shall not be eligible for consideration for any award other than the awards meant for the best children, educational and best Tele pictures.
(b) Subject to provisions of these Rules, the T.V. Serials / Tele Films shall be eligible for consideration of awards which are in Odia language that have been produced inside Odisha between 1st January to 31st December of the year to which the award relates. The Producer of the Tele Serial need to submit synopsis for a duration of one hour in DVD format which should contain the materials of **at least 52 serials** produced & exhibited in a Calendar year from **1st January to 31st December. (in the instant year it may be read as 01.01.2012 to 31.12.2012)** Besides, the Producer should also illustrate in clear-cut terms for the specific category / categories of awards for which he / she has applied for. Further, a ten minute clippings on the category / categories of awards applied must also be submitted for enabling the Jury Committee to take their valued decision.

3. The following T.V. Serials / Tele Films shall be ineligible for entry:

- (a) Remake of a T.V. Serials / Tele Films that has already own a State Award in a particular category.
- (b) Dubbed / revised / copied / remake version of a T.V. Serials / Tele Films.
- (c) T.V. Serials / Tele Films that relates to threat to National Integrity, Sovereignty and Religious Harmony.
- (d) Performance of an artist where his / her voice and dialogue are dubbed by some other artist(s).

4. AWARDS.

- (a) The awards, which will be given, are indicated in **Schedule-1** to these Rules. This shall be rearranged as 1 to 20 as indicated in **Schedule-1**.
- (b) Violation of provision of this rule or the Copy Right Act if proved will disqualify the Odisha State Tele Awards and or will result in cancellation of the award if won at anytime.

5. LAST DATE FOR RECEIPT OF ENTRY.

Last date for receipt of application of awards envisaged under Rule's along with the print / prints in the Directorate of Culture, Govt. of Odisha shall be 30.09.2013 for the year 2013. From the year 2014 and onwards, the last date for receipt of application of awards envisaged under Rule's along with the print / prints in the

Directorate of Culture, Govt. of Odisha shall be the last working day in the month of August of the year following the year to which the awards relate to .

6. PROCEDURE FOR ENTRY OF T.V. SERIALS / TELE FILMS / DOCUMENTARIES.

- (i) The T.V. Serials / Tele Films shall be entered only by its Producer.
- (ii) A T.V. Serials / Tele Films may be entered for all the awards or for one.

7. The Producers shall submit his / her entry in the **Entry Form given in Schedule-II** in duplicate. The form shall be complete in all respects and shall be accompanied by all materials mentioned in **Rule-9** failing which the entry is liable to be rejected.

8. The following shall be furnished along with the Entry Form.

- (a) A print of the T.V. Serials / Tele Films as certified by the self authorization from the concerned Producer of the Tele Serial.
- (b) A non-refundable entry fee of Rs.3,000/- for T.V. Serials / Tele Films.
- (c) 10 copies of the Text of the commentary in the original language in case of T.V. Serials / Tele Films.
- (d) Short biographical sketches of Producer, Director, Screen Play Writer, Leading and Supporting Artists, Cameraman, Audiographer, Editor. Provided that if a T.V. Serials / Tele Films is being entered for specific award / awards, biographical sketches should relate to the persons who are to be applied for by the Producer for the award / awards.
- (e) Two copies of the self authorization by the Producer in Non-Judicial Stamp Paper that the serial does not contain any obscene or objectionable materials detrimental to socio-cultural integrity and anti-Government campaign. In case of detection of such incident, the award(s) so conferred will be withdrawn from the concerned awardee.

9. The cost of sending the print and other materials to the Directorate of Culture and the cost of return shall be borne by the entrant.

10. The Directorate reserves the right to reject any entry if the print and other documents prescribed under this rule are not received by the prescribed date.

11. PROCEDURE FOR SELECTION.

- (i) The awards shall be decided by a Jury to be constituted by the State Government for each year.
- (ii) The Jury shall be composed of a Chairman and not more than 6 Members distinguished in the field of T.V. Serials / Tele Films / performing and other allied arts and humanities.
- (iii) Any person directly or indirectly associated with T.V. Serials / Tele Films entered for consideration of the award shall not be eligible to act as a Member of the Jury.
- (iv) The Jury will determine their own work procedure.
- (v) The Chairman of the Jury may seek advice of the experts in specialized areas whenever necessary.
- (vi) The quorum for the meeting of the Jury shall be 50 percent of the Members of the Jury and the Chairman.
- (vii) In case of difference of opinion, the opinion of the majority of the Members of the Jury including the Chairman shall be deemed to be the recommendation of the Jury. In the event of equality of votes, the Chairman shall have a casting vote.

- (viii) The Jury shall have the discretion to recommend that any one or more awards may not be given for a particular year if they are of the opinion that entries for that or these awards are not of the required standard.
- (ix) The Producer of the Tele Serial should submit synopsis for a duration of one hour in DVD format which should contain the compressed materials for at least 52 serials produced & exhibited in a Calendar year i.e. from 1st January, 2012 to 31st December, 2012.
- (x) The Producer of the Tele Film should submit synopsis for a minimum duration of twenty five minutes in DVD format which should contain the materials produced & exhibited for the said Tele Film.
- (xi) The Tele Serial once awarded under category of " Best Tele Serial Award shall not be awarded for the subsequent three years in succession.

12. The T.V. Serials / Tele Films in respect of which valid entries have been made shall be screened for purpose of selection of awardees at such place and time as may be determined by the Director, Culture in consultation with the Chairman of the Jury.

13. The awards shall be presented on the date as decided by the State Government.

14. The T.V. Serials / Tele Films recorded in DVD shall be sent at the owner's risk and neither the State Government nor the Jury shall be responsible for the loss or damage to the CD / DVD while in dispatch.

15. GENERAL.

- (a) Government shall have right to amend / modify the above Rules from time to time to make these Rules operational.
- (b) The decision of the State Govt. in respect of matters covered by these Rules and all the interpretations of these Rules shall be final.

- (f) Violation of provision of this rule or the Copy Right Act if proved will disqualify the Odisha State Tele Awards and or will result in cancellation of the award if won at anytime.

5. KABI CHANDRA KALICHARAN PATTANAİK SAMMAN.

In addition to the awards mentioned in **Schedule-1**, the State Government may on the recommendation of the Jury constituted under Rule-12 and in its discretion give an award called "The Punyatoya Award" to a T.V. personality for outstanding contribution to the growth and development of Odia T.V. Serials / Tele Films / Documentaries (minimum 20 years) which shall consist of a certificate of honour with a cash prize of Rs.1,00,000/- (Rupees one lakh) only and a shawl.

6. LAST DATE FOR RECEIPT OF ENTRY.

Last date for receipt of application of awards envisaged under Rule's along with the print / prints in the Directorate of Culture, Govt. of Odisha shall be the last working day in the month of February of the year following the year to which the awards relate.

7. PROCEDURE FOR ENTRY OF T.V. SERIALS / TELE FILMS / DOCUMENTARIES.

- (i) The T.V. Serials / Tele Films / Documentaries shall be entered only by its Producer.
- (ii) A T.V. Serials / Tele Films / Documentaries may be entered for all the awards or for one.

8. The Producers shall submit his / her entry in the **Entry Form given in Schedule-II** in duplicate. The form shall be complete in all respects and shall be accompanied by all materials mentioned in **Rule-9** failing which the entry is liable to be rejected.

9. The following shall be furnished along with the Entry Form.

- (g) A print of the T.V. Serials / Tele Films / Documentaries as certified by the self authorization from the concerned Producer of the Tele Serial.
- (h) A non-refundable entry fee of Rs.3,000/- for T.V. Serials / Tele Films / Documentaries.
- (i) 10 copies of the Text of the commentary in the original language in case of T.V. Serials / Tele Films / Documentaries.
- (j) 10 copies of the lyrics, if any, each in original language.
- (k) Short biographical sketches of Producer, Director, Screen Play Writer, Leading and Supporting Artists, Cameraman, Animator, Audiographer, Editor, Art Director, Costume Designer, Lyricist, Music Director and Playback Singer. Provided that if a T.V. Serials / Tele Films / Documentaries is being entered for specific award / awards, biographical sketches should relate to the persons who are to be applied for by the Producer for the award / awards.
- (l) Two copies of the self authorization by the Producer in Non-Judicial Stamp Paper that the serial does not contain any obscene or objectionable materials detrimental to socio-cultural integrity and anti-Government campaign. In case of detection of such incident, the award(s) so conferred will be withdrawn from the concerned awardee.

10. The cost of sending the print and other materials to the Directorate of Culture and the cost of return shall be borne by the entrant.

11. The Directorate reserves the right to reject any entry if the print and other documents prescribed under this rule are not received by the prescribed date.

12. PROCEDURE FOR SELECTION.

- (k) The awards shall be decided by a Jury to be constituted by the State Government for each year.
- (ii) The Jury shall be composed of a Chairman and not more than 6 Members distinguished in the field of T.V. Serials / Tele Films / Documentaries / performing and other allied arts and humanities.
- (iii) Any person directly or indirectly associated with T.V. Serials / Tele Films / Documentaries entered for consideration of the award shall not be eligible to act as a Member of the Jury.
- (iv) The Jury will determine their own work procedure.
- (v) The Chairman of the Jury may seek advice of the experts in specialized areas whenever necessary.
- (vi) The quorum for the meeting of the Jury shall be 50 percent of the Members of the Jury and the Chairman.
- (vii) In case of difference of opinion, the opinion of the majority of the Members of the Jury including the Chairman shall be deemed to be the recommendation of the Jury. In the event of equality of votes, the Chairman shall have a casting vote.
- (viii) The Jury shall have the discretion to recommend that any one or more awards may not be given for a particular year if they are of the opinion that entries for that or these awards are not of the required standard.
- (ix) The Jury constituted under this Rules may also make recommendation for the Punyatoya Award and provision of this Rules shall mutates mutandis apply to the recommendation of the Jury.
- (x) The Producer of the Tele Serial should submit synopsis for a duration of one hour in DVD format which should contain the compressed materials for at least 52 serials produced & exhibited in a Calendar year i.e. from 1st January, 2012 to 31st December, 2012.

(xi) The Producer of the Tele Film should submit synopsis for a minimum duration of twenty five minutes in DVD format which should contain the materials produced & exhibited for the said Tele Film.

(xii) The Tele Serial once awarded under category of " Best Tele Serial Award shall not be awarded for the subsequent three years in succession.

13. The T.V. Serials / Tele Films / Documentaries in respect of which valid entries have been made shall be screened for purpose of selection of awardees at such place and time as may be determined by the Director, Culture in consultation with the Chairman of the Jury.

14. The awards shall be presented on 26th November of each year as decided by the State Government.

15. The T.V. Serials / Tele Films / Documentaries recorded in CD / DVD shall be sent at the owner's risk and neither the State Government nor the Jury shall be responsible for the loss or damage to the CD / DVD while in dispatch.

16. **GENERAL.**

(a) Government shall have right to amend / modify the above Rules from time to time to make these Rules operational.

(b) The decision of the State Govt. in respect of matters covered by these Rules and all the interpretations of these Rules shall be final.

(c) Any person submitting an entry for any one or more of the awards shall be deemed to have accepted these Rules.
